Singhal (President, INC-IAH) is pleased to inform that Indian Chapter of IAH has planned to organise a National Seminar on the topic of 'Resilience of Groundwater Resources---Climatic Changes' in Jamia Millia University, New Delhi on November 07 2020 in which we are also expecting good inputs from AGGS members. The timing of the Seminar, being close to the deferred 36 IGC, now rescheduled from November 09 2020 onwards, is also expected to draw some of the interested delegates coming from far off places in India and overseas countries to attend the IGC in Delhi.
